# **Discussions and decisions**

### Information about the status

- Technical problems concerning access to E-library on the Moodle of BSU. Temporally solution is achieved: access is provided to particular URL addresses of the project team members (info from Sergey H., BSU).
- Process of accreditation in Belarusian Government still is not finished (info from Sergey H., BSU).
- On-line preventive monitoring meeting October 29<sup>th</sup> (info from Anatolijs Z., RTU).

## Decision:

1) To look for long term solution concerning access to e-library and to inform the partners (BSU team).

## Purchase of equipment KhNAHU, CPNU and KNU

- KhNAHU and CPNU have finished purchase of the labs equipment. KNU implemented 2 lots and signed agreements with suppliers. Next probably two lots are scheduled.
- RTU transferred advances for equipment to Ukrainian partners.
