Project progress

- RTU is going to finance three e-books electronic issue: 3 (CPNU), 6 (UCY), and 7 (KhNAHU).
- RTU has sent a formal request to EACEA, in which RTU asked permission to continue the project, while the participation of Belarusian partners is suspended – 14.07.21.
- The progress report will be analysed in August and the payment will be made soon afterwards.
- "Regarding the suspension of BY partners, I am afraid I cannot deal with it at the moment, as I did not receive instructions on how to treat your request from a legal and procedural angle".
- "I have to wait for my legal colleagues to come back from their summer break".
